WITNESSETH that for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, receipt and sufficiency of which is hereby acknowledged, the grantor hereby gives, grants, bargains and releases to the grantee, a temporary construction easement for the purpose of removing the existing Bridge No. 740069 over Lofton Creek and construct a new bridge along the existing bridge alignment and tying in, conforming, harmonizing, and/or reconnecting existing grade, slope, pavement, drainage, utility, driveway, walkway, turnout, and/or other features located on or within the real property described below in Nassau County, Florida, with the construction undertaken by the Department on adjacent County Road No. 200A, as part of the above-referenced financial project (collectively the "Reconnection Work"), together with related incidental purposes necessary to complete the Reconnection Work.

THIS EASEMENT shall be for a period of fifty-four (54) months commencing on the date the State of Florida Department of Transportation becomes the owner of this easement.
