



**AMENDMENT NO. 01/FIRST EXTENSION TO THE
CONTRACT FOR ASPHALTIC CONCRETE - SI, SII AND MILLINGS**

THIS AMENDMENT entered into this 26th day of September, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and Preferred Materials, Inc., located at 11482 Columbia Park Drive W., Suite 3, Jacksonville, Florida 32258, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Asphaltic Concrete - SI, SII and Millings* (hereinafter referred to as "Contract") on or about February 23, 2018; and

WHEREAS, the original *Contract* provided for an initial term beginning February 23, 2018 and terminating September 30, 2019, with an option for two (2) extensions in one (1) year increments upon mutual contract between the Vendor and the County; and

WHEREAS, the parties desire to extend the *Contact*.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 20 of the *Contract*, the performance period is hereby extended for an additional

one (1) year beginning October 1, 2019 and terminating September 30, 2020.

2. All other provisions of the Contract not in conflict with this Amendment shall remain in full force and effect.


