This letter is to confirm that this firm will be pleased to continue representing you and to start representing Nassau County in connection with the above referenced lawsuit. This letter memorializes the terms of our engagement.

John Woodlee and I will be primarily responsible for handling this matter. Other lawyers in the firm may help us from time to time. We will bill for our work on an hourly basis. I will bill my work at \$360 per hour. John will bill his work at \$275 per hour. (Both of those rates are a substantial discount from our standard hourly rates.) The rates of other lawyers in the firm vary, based on their experience at the bar. Our legal assistants bill at \$160 per hour. Nassau County will be responsible for the payment of our bills.

The County will also be responsible for our expenses, such as long distance telephone calls, copying costs, delivery and mailing charges, travel costs, expert witness fees, and other litigation costs. We will send monthly statements describing these costs, as well as the nature of any work we have performed and the amount of time we devoted to various tasks.




