**AMENDMENT NO. 01/FIRST EXTENSION TO THE
PIGGYBACK AGREEMENT OFF OF LEE COUNTY'S AGREEMENT FOR
ALTERNATIVE PAVING METHODS**

THIS AMENDMENT entered into this 5th day of November, 2019 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **Asphalt Paving Systems, Inc.**, located at 500 N Egg Harbor Road, Hammonton, New Jersey 08037, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement on or about January 16, 2019; and

WHEREAS, the Agreement provided for an initial term beginning September 5, 2017 and terminating September 4, 2018, with an option for three (3) extensions in one (1) year increments upon mutual contract between the Vendor and the County; and


WHEREAS, on or about July 13, 2018, the parties extended the Agreement for an additional one (1) year period beginning September 5, 2018 and terminating September 4, 2019; and

WHEREAS, the parties desire to extend the Agreement once again for a one (1) year period.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with the terms of the Agreement, the performance period is hereby extended for an additional one (1) year beginning September 5, 2019 and terminating September 4, 2020.
