FIRST AMENDMENT TO EXTEND THE AGREEMENT FOR MISDEMEANOR PROBATION SERVICES FOR JUDICIAL CIRCUIT, IN AND FOR NASSAU COUNTY, FLORIDA

THIS AMENDMENT made and entered into this 3rd day of December, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the FOURTH JUDICIAL CIRCUIT COURT, in and for Nassau County, pursuant to the authority of the Chief Administrative Judge, hereinafter referred to as the "Court", and CLEAR VIEW TRANSFORMATION, INC., authorized in the State of Florida as a non-profit corporation, 1411 South 14th Street, Building K, Fernandina Beach, FL 32034, hereinafter referred to as "Contractor".

WHEREAS, the County entered into a third-party Contract on December 11, 2017 for private misdemeanor probation services to be administered and supervised by the Office of the Court Administrator of the Fourth Judicial Circuit of Florida and by the Nassau County Administrative Judge; and

WHEREAS, the Contract provided for an initial term beginning December 11, 2017 and ending December 10, 2019, with an option to extend upon agreement between the parties; any extension of performance period under this provision shall be in one (1) year increments and shall be upon recommendation of the Nassau County Administrative Judge to the Board of County Commissioners of Nassau County; and

WHEREAS, the parties desire to amend and extend said Contract for an additional one (1) year beginning December 11, 2019 and ending December 10, 2020; and

WHEREAS, pursuant to Section 3.1 of the Contract, the Court Administrator and the Nassau County Administrative Judge agree to increase the monthly fee the Contractor is entitled to collect from each probationer from \$55 to \$60 per month.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

- In accordance with Section 2.1, Term and Renewal, of the Contract dated December 11, 2017, the Contract is hereby extended for an additional one (1) year beginning December 11, 2019 and ending December 10, 2020.
- In accordance with Section 3.1, the monthly fee the Contractor is entitled to collect from each probationer will be increased from \$55 per month to \$60 per month.
- All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
