INTERLOCAL AGREEMENT FOR ANIMAL CONTROL SERVICES BETWEEN NASSAU COUNTY AND TOWN OF CALLAHAN

WHEREAS, it is of benefit to all citizens of the Town and County that both governments cooperate to provide efficient and effective services; and

WHEREAS, pursuant to § 125.0101, Florida Statues, the County may contract with a municipality for essential facilities and municipal services; and

WHEREAS, the Town and County recognize the importance of animal control services for the health, safety, and welfare of the Town and County; and

WHEREAS, the parties agree that the County will provide animal control services to the Town pursuant to the County's and the Town's Animal Control Ordinances, as well as Florida Statutes that deal with animal control.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter contained, the parties hereto agree as follows:

- The Town will pay a monthly fee from October 1, 2019 September 30, 2020 of \$1,075.00. Said fee will be adjusted annually on October 1st by five percent (5%). See following "Schedule"
 - a. Fiscal Year 2019 2020 \$1,075.00 x 12 months = \$12,900.00

7. The County will maintain a program of public education covering licensing, animal related laws,

and promoting responsible pet ownership.

8. Neither the County nor the Town shall assign this Agreement without the prior written consent

of the other party.

9. The County shall hold the Town harmless from any and all liability for the County's acts in the

performance of this Agreement, except that nothing contained herein shall constitute a waiver

of immunity or limitation of liability the Town or County may have under the doctrine of

sovereign immunity or Section 768.28, Florida Statutes.
