

FOUETEENTH AMENDMENT TO AGREEMENT WITH NASSAU COUNTY
ECONOMIC DEVELOPMENT BOARD, INC.

THIS AGREEMENT made and entered into this 9th day of December, 2019 by and between the **Board of County Commissioners of Nassau County, Florida**, a political subdivision of the State of Florida, hereinafter referred to as the "Board", and the **Nassau County Economic Development Board, Inc.**, 76346 William Burgess Boulevard, Yulee, Florida 32097.

WHEREAS, the Nassau County Economic Development Board, Inc., has been formed to further economic development in Nassau County; and

WHEREAS, the Board is desirous of successful economic development within Nassau County that will provide new jobs and broaden the tax base; and

WHEREAS, the Board and the Nassau County Economic Development Board, Inc., entered into an Agreement on May 11, 1998 to provide funding to the Nassau County Economic Development Board, Inc., in order to further economic development efforts; and

WHEREAS, the Board and the Nassau County Economic Development Board, Inc., have approved renewals and amendments since 1998; and

WHEREAS, the parties desire to amend and extend said Agreement.


NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

1. This Agreement shall be effective for the period October 1, 2019 through September 30, 2020, unless terminated by either party upon thirty (30) days written notice to the other party, subject to completion of all previous and outstanding billings.
2. The funding for Fiscal Year 2019-2020 shall be One Hundred-Fifty Thousand Dollars (\$150,000.00), which shall be paid in quarterly installments of Thirty-Seven Thousand Five Hundred Dollars (\$37,500.00), during the months of December, February, May and August of the fiscal year.
3. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
4. Time is of the essence.


