# AMENDMENT NO. 3/THIRD EXTENSION TO THE CONTRACT FOR BOTTLED WATER SERVICE

WHEREAS, the parties entered into a *Contract for Bottled Water Service* (hereinafter referred to as "Contract") on or about November 22, 2016;

WHEREAS, the *Contract* provided for an initial term beginning December 1, 2016 and ending November 30, 2018, with an option to extend upon mutual contract between the Vendor and the County; and shall allow for one (1) year extensions with the total contract length and individual one (1) year extensions not to exceed five (5) years; and

WHEREAS, the parties agreed to extend the *Contract* on December 12, 2018 for a period of one (1) year beginning December 1, 2018 and terminating on November 30, 2019; and

WHEREAS, the parties desire to extend the *Contract* for an additional one (1) year term; and

WHEREAS, the parties desire to modify the pricing for the extension period from December 1, 2019 to November 30, 2020 pursuant to Section 11 of the *Contract* and as outlined in Exhibit "1" attached hereto and incorporated herein.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- In accordance with Section 20 of the Contract, the performance period is hereby extended for an additional one (1) year beginning December 1, 2019 and ending November 30, 2020.
- 2. In accordance with Section 11 of the Contract, the unit costs are modified for the extension period of December 1, 2019 to November 30, 2020 as outlined in Exhibit "1" attached hereto and incorporated herein.
- 3. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
