## AMENDMENT NO. 5/ FIFTH EXTENSION TO THE AGREEMENT FOR SPAY/NEUTER SERVICES AND RABIES VACCINATIONS

THIS AMENDMENT entered into this day of January, 2019 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and FIRST COAST NO MORE HOMELESS PETS, 6817 Norwood Avenue, Jacksonville, FL 32208, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated January 13, 2014 for spay/neuter services and rabies vaccinations; and

WHEREAS, the Agreement provided for an initial term of two (2) years beginning January 13, 2014 and ending January 12, 2016, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties extended said Agreement for subsequent one-year terms beginning January 13, 2016 and ending January 12, 2020.

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 18 of the Agreement for Spay/Neuter Services and Rabies Vaccinations dated January 13, 2014, the performance period is hereby extended for an additional one (1) year beginning January 13, 2020 and ending January 12, 2021.
- 2. The Vendor will honor the same rates for FY2019/2020 for the following services:
