




AMENDMENT NO. 4/THIRD EXTENSION TO THE
CONTRACT FOR BEACH AND PARK CLEANING SERVICES

THIS AMENDMENT entered into this 30 day of January, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **ROLLINS SNELLING BEACH SERVICES, LLC**, 9 Water Oak, Fernandina Beach, Florida 32034, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into the *Contract for Beach and Park Cleaning Services* on January 18, 2017 providing for an initial term beginning February 1, 2017 and ending January 31, 2018; and

WHEREAS, said Contract provided an option to extend the initial term upon mutual agreement between the Vendor and the County; and

WHEREAS, on November 13, 2017, the parties agreed to extend said Contract for a period of one (1) year beginning February 1, 2018 and ending January 31, 2019; and

WHEREAS, on January 28, 2019, the parties agreed to extend said Contract for a period of one (1) year beginning February 1, 2019 and ending January 31, 2020; and

WHEREAS, the parties desire to amend said Contract for an additional one (1) month beginning February 1, 2020 and ending February 29, 2020; and


WHEREAS, all provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended for a period of one (1) month beginning February 1, 2020 and ending February 29, 2020.
2. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
