## AMENDMENT NO. 1/ TO THE INTERLOCAL AGREEMENT BETWEEN THE PROPERTY APPRAISER AND THE NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS FOR GIS SERVICES

THIS AMENDMENT made and entered into this <u>19</u> day of FCDTUARY, 2020 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and THE NASSAU COUNTY PROPERTY APPRAISER located at 96135 Nassau Place, Suite #4, Yulee, Florida 32097 (hereinafter referred to as "Appraiser".

WHEREAS, the parties entered into an Agreement on September 26, 2016 to coordinate the efforts of the County Appraiser in the effective utilization of the Appraiser's Geographical Information System "GIS" Website; and

WHEREAS, the Agreement initially provided for GIS services support provided to all departments at forty (40) hours in a typical work week by the Appraiser in Section 2, Custom Works and Deliverable; and

WHEREAS, the Agreement initially provided for a yearly compensation fee due to the Appraiser of fifty-five thousand dollars (\$55,000.00) in Section 3, Web Delivered Services;

WHEREAS, the parties desire to amend said Agreement Section 2, Custom Works and Deliverables, and increase the hours from forty (40) hours in a typical work week with up to sixty (60) hours in a typical work week; and

WHEREAS, the parties desire to amend said Agreement Section 3, Web Delivered Services, and increase the yearly fee due to the appraiser from fifty-five thousand dollars (\$55,000.00) to ninety-five thousand dollars (\$95,000.00)

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- Increase the hours from forty (40) hours in a typical work week with up to sixty (60) hours in a typical work week in Section 2, Custom Work and Deliverables
- Increase the yearly fee due to the Appraiser to ninetyfive thousand dollars (\$95,000.00) in Section 3, Web Delivered Services.
- 3. All other provisions of the original Agreement, as amended, not in conflict with this Amendment shall remain in full force and effect.
