**AMENDMENT NO. 2/SECOND EXTENSION TO THE CONTRACT FOR
SAISSA PROJECT SHOREBIRD MONITORING SURVEYS**

This Amendment entered into this 10 day of March, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **ENVIRONMENTAL SCIENCE ASSOCIATES (ESA)**, located at 5892 East Fowler Avenue, Tampa, FL 33617; (hereinafter referred to as "Contractor").

WHEREAS, on April 4, 2017, the County and Scheda Ecological Associates, Inc. entered into the Contract for SAISSA Project Shorebird Monitoring Surveys (hereinafter referred to as "Contract"); and

WHEREAS, the Contract provided for an initial performance period beginning April 1, 2017 and ending April 30, 2019 with the ability to extend the Contract for two (2) additional twelve (12) month periods upon written agreement of both parties; and

WHEREAS, on January 1, 2019, the Contractor became the successor to Scheda Ecological Associates Inc. and agrees to abide by the terms of the Contract; and


WHEREAS, the County and the Contractor desire to extend the Contract for a period of twelve (12) months beginning May 1, 2019 and ending April 30, 2020; and

WHEREAS, the parties desire to amend and extend said contract for an additional twelve (12) months beginning May 1, 2020 and ending April 30, 2021.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 3 of the Contract dated April 4, 2017, the performance period is hereby extended for an additional twelve (12) months beginning May 1, 2020 and ending April 30, 2021.
2. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
3. Time is of the essence.
