





**AMENDMENT NUMBER TWO/FIRST EXTENSION TO THE
AGREEMENT FOR DELIVERY OF RECYCLABLE MATERIALS**

This Amendment entered into this 26th day of March, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **REPUBLIC SERVICES OF FLORIDA, LIMITED PARTNERSHIP**, 7000 Imeson Road Jacksonville, Florida 32219 (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated June 4, 2019, for Delivery of Recyclable Materials; and

WHEREAS, the Agreement provided for a term of June 1, 2019 through May 31, 2020 with an option to extend the term for one twelve (12) consecutive month term


WHEREAS, the County desires to extend the contract for one twelve (12) consecutive month term "Renewal Term" detailed in Section 4, Term, of the Agreement; and

3. Time is of the essence.


