**AMENDMENT NUMBER ONE/FIRST SERVICE INCREASE TO THE
CONTRACT FOR GARBAGE SERVICES FOR COUNTY PARK AND
FACILITY LOCATIONS**

This Amendment entered into this 19 day of April, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **MERIDIAN WASTE**, located at 463106 SR 200, Yulee, Florida 32097 (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a Contract dated October 8, 2019, for Garbage Services for the County Park and Facility Locations; and

WHEREAS, the Contract provided for trash pick-up of twice a week at the James Page Governmental Building for a monthly cost of \$175.00; and

WHEREAS, the parties desire to amend this Contract to increase the trash pick-up at the James Page Governmental Building from twice (2) a week to three (3) times a week for a monthly cost of \$235.00 effective on April 2, 2020.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. Increase trash pick-up at the James Page Governmental Building from twice (2) a week to

three (3) times a week for a monthly cost of \$235.00 effective 4/2/2020.

2. All other location pick-ups and monthly cost shall remain the same and not be affected by the increase at the James Page Governmental Building detailed in this Amendment.
3. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
