**AMENDMENT NO. 2/SECOND EXTENSION TO THE  
PROFESSIONAL SERVICE CONTRACT FOR NASSAU COUNTY**

THIS AMENDMENT entered into this 4<sup>th</sup> day of May, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **BARTH ASSOCIATES, LLC**, 10030 SW 52<sup>nd</sup> Road, Gainesville, Florida 32608, (hereinafter referred to as "Consultant").

**WHEREAS**, the parties entered into an Agreement dated May 11, 2018 for professional services on an as-needed basis for parks and recreation services planning; and

**WHEREAS**, the original Agreement provided for an initial term beginning May 11, 2018 and ending May 10, 2019, with an option to extend upon mutual contract between the Consultant and the County; any extension of performance period under this provision shall be in one (1) year increments; and

**WHEREAS**, the parties extended the agreement for one (1) year beginning May 11, 2019 and ending May 10, 2020; and

**WHEREAS**, the parties desire to amend and extend the Agreement through the end of the fiscal year ending September 30, 2020 for professional services on as-needed basis; and


**WHEREAS**, the parties desire to increase the amount of the Agreement by an additional NTE \$10,000.00.


**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


