**AMENDMENT NO. 1 / FIRST EXTENSION TO THE AGREEMENT**  
**FOR PROFESSIONAL SERVICES**

THIS AMENDMENT entered into this 16<sup>th</sup> day of May, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **CDM SMITH, INC.**, located at 75 State Street, Suite 701, Boston, MA 02109 (hereinafter referred to as "Consultant").

**WHEREAS**, on June 12, 2017, the County and the Consultant entered into the Professional Services Agreement for Construction Engineering Inspection (CEI) services; and

**WHEREAS**, the Agreement provided for an initial performance period of three (3) years beginning June 12, 2017 and ending June 11, 2020, with an option to extend upon mutual agreement between the Consultant and the County; and

**WHEREAS**, the parties desire to amend and extend the Agreement for one (1) year beginning June 12, 2020 and ending June 11, 2021.


**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:
