WHEREAS, the Board and the Consultant entered into an agreement on November 21, 2016 to provide professional engineering design services; and

WHEREAS, on August 28, 2017, the parties agreed to amend the original Agreement adding additional services to the original Scope of Services; and

WHEREAS, on January 22, 2019, the parties agreed to amend the original Agreement again adding additional services to the original Scope of Services; and

WHEREAS, the original Agreement provided for an initial performance period beginning November 21, 2016 and ending November 20, 2018, with an option to extend upon mutual agreement between the Consultant and the County; and

WHEREAS, on December 26, 2018, the parties agreed to amend the original Agreement extending the performance period from November 21, 2018 to May 21, 2019; and

WHEREAS, on July 26, 2019, the parties agreed that additional time was needed to complete the additional services added to the original Scope of Services and extended the performance period from May 22, 2019 to May 21, 2020.

WHEREAS, the parties agree that additional time is needed to provide post design services and complete the design of the Pages Dairy/Chester Road Intersection Improvements

and desire to extend the performance period for an additional seven (7) months, beginning May 22, 2020 to December 31, 2020.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- In accordance with Article 4 of the original Agreement dated November 21, 2016, the performance period is hereby extended for an additional seven (7) months beginning May 22, 2020 and ending December 31, 2020.
- All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.
