


AMENDMENT NO. 01/FIRST EXTENSION TO THE CONTRACT FOR FIRE RESCUE T-SHIRTS AND BALL CAPS

THIS AMENDMENT entered into this _____ day of _____, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **P5 Productions**, located at 1875 S. 14th Street, Fernandina Beach, FL 32034, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a Contract on August 9, 2019 for Nassau County Fire Rescue T-Shirts and Ball Caps; and

WHEREAS, the Contract provided for an initial term of twelve (12) months beginning August 9, 2019 and terminating August 8, 2020, with an option for two (2) extensions of the performance period in one (1) year increments upon mutual contract between the Vendor and the County; and

WHEREAS, the parties desire to amend and extend the Contract for one (1) year beginning August 9, 2020 and ending August 8, 2021.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with the terms of the Contract, the performance period is hereby extended for an additional

one (1) year beginning August 9, 2020 and ending August 8, 2021.

2. All other provisions of the Contract not in conflict with this Amendment shall remain in full force and effect.
