





AMENDMENT NO. 02/SECOND EXTENSION TO THE
CONTRACT FOR COLD PLANT MIX

THIS AMENDMENT entered into this 8th day of September, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Duval Asphalt Products, Inc.**, located at 7544 Philips Highway, Jacksonville, Florida 32256 hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Cold Plant Mix* (hereinafter referred to as "Contract") on or about September 25, 2017; and

WHEREAS, the original *Contract* provided for an initial term beginning October 1, 2017 and terminating September 30, 2019, with an option to extend in one (1) year increments upon mutual contract between the Vendor and the County; and


WHEREAS, the parties agreed to extend the terms of the *Contract* for an additional one (1) year period beginning October 1, 2019 and ending September 30, 2020; and

WHEREAS, the parties desire to extend the terms of the *Contract* once again for an additional one (1) year.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


