

**AMENDMENT NO. 04/SECOND EXTENSION TO THE
CONTRACT FOR UNIFORM SHIRT RENTAL**

THIS AMENDMENT entered into this 22nd day of September, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **Unifirst Corporation**, located at 1446 Haines Street, Jacksonville, Florida 32206, hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Uniform Shirt Rental* (hereinafter referred to as "Contract") on or about November 13, 2017; and

WHEREAS, the original *Contract* provided for an initial term beginning October 1, 2017 and terminating September 30, 2019, with an option for two (2) extensions in one (1) year increments upon mutual contract between the Vendor and the County; and

WHEREAS, upon expiration of the initial term, the parties agreed to extend the terms of the agreement for an addition one (1) year period beginning October 1, 2019 and ending September 30, 2020; and

WHEREAS, the parties desire to extend the terms of the agreement for a second one (1) year period beginning October 1, 2020 and ending September 30, 2021.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 20 of the *Contract*, the performance period is hereby extended for an additional one (1) year beginning October 1, 2020 and terminating September 30, 2021.
2. All other provisions of the *Contract* not in conflict with this Amendment shall remain in full force and effect.
