**AMENDMENT NO. 4 TO THE**  
**PROFESSIONAL SERVICE AGREEMENT FOR NASSAU COUNTY**

THIS AMENDMENT entered into this 2nd day of December, 2020 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, hereinafter referred to as "County", and **Government Services Group, Inc. (GSG)** located at 1500 Mahan Drive, Suite 250, Tallahassee, Florida, 32308, hereinafter referred to as "Consultant".

**WHEREAS**, the parties entered into an Agreement dated June 24, 2020, for professional services for the development of the County's CARES Act Plan; and

**WHEREAS**, the Agreement provided for an initial term beginning June 29, 2020 and ending July 31, 2020; and

**WHEREAS**, on July 6, 2020, the Board of County Commissioners directed staff to negotiate a contract with GSG for professional services in relation to the CARES Act Expenditure Plan; and

**WHEREAS**, on July 29, 2020 the parties amended and extended the Agreement for an additional two (2) weeks beginning August 1, 2020, and ending August 15, 2020; and

**WHEREAS**, on August 12, 2020 the parties amended and extended the Agreement for an additional two (2) weeks beginning August 16, 2020, and ending August 30, 2020; and

**WHEREAS**, on August 26, 2020 the parties amended and extended the Agreement for an additional four (4) months beginning August 31, 2020, and ending December 30, 2020; and


**WHEREAS**, the parties desire to extend the Agreement once again for a period beginning December 31, 2020 and ending April 1, 2021.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. This Agreement is hereby amended to extend the term beginning December 31, 2020 and ending April 1, 2021.
2. All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.


