### AMENDMENT NO. 4 TO THE PROFESSIONAL SERVICE AGREEMENT FOR NASSAU COUNTY

THIS AMENDMENT entered into this <u>And</u> day of <u>December</u>, 20 <u>2D</u> by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "County", and Government Services Group, Inc. (GSG) located at 1500 Mahan Drive, Suite 250, Tallahassee, Florida, 32308, hereinafter referred to as "Consultant".

WHEREAS, the parties entered into an Agreement dated June 24, 2020, for professional services for the development of the County's CARES Act Plan; and

WHEREAS, the Agreement provided for an initial term beginning June 29, 2020 and ending July 31, 2020; and

WHEREAS, on July 6, 2020, the Board of County Commissioners directed staff to negotiate a contract with GSG for professional services in relation to the CARES Act Expenditure Plan; and

WHEREAS, on July 29, 2020 the parties amended and extended the Agreement for an additional two (2) weeks beginning August 1, 2020, and ending August 15, 2020; and

WHEREAS, on August 12, 2020 the parties amended and extended the Agreement for an additional two (2) weeks beginning August 16, 2020, and ending August 30, 2020; and

WHEREAS, on August 26, 2020 the parties amended and extended the Agreement for an additional four (4) months beginning August 31, 2020, and ending December 30, 2020; and

WHEREAS, the parties desire to extend the Agreement once again for a period beginning December 31, 2020 and ending April 1, 2021.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. This Agreement is hereby amended to extend the term beginning December 31, 2020 and ending April 1, 2021.
- 2. All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.
