This Work Authorization is to the AGREEMENT between Nassau County and the Consultant known as the Interlocal Agreement between Nassau County and Florida Governmental Utility Authority for Water and Wastewater Utility Capital Project and related Grant/Loan Administration and Special Assessment Services, dated December 12, 2019. The services to be provided under this Work Authorization are as follows:

## ARTICLE 1. Services Described as:

The Consultant shall assist the County in carrying out all Engineering Services, Capital Project Administration, and Inspection services necessary during the construction phase of the Amelia Island WWTP Generator Replacement Project. These services shall include project management, review of technical submittals, preparation of meeting agendas and minutes, review of construction contractor payment applications, coordination with plant operations and field inspection services.

### ARTICLE 2. Time Schedule

The Consultant shall complete the Work within five (5) months of the Notice to Proceed being issued to the construction Contractor by the County.

### ARTICLE 3. Budget

The Consultant will perform the Engineering and Capital Project Administration scope of services outlined herein for the lump sum amounts of \$10,400.00 and \$7,178.95, respectively. Copies of the related GAI Consultants, Inc. and Government Services Group, Inc. Work Authorizations are attached hereto for reference. The fee for Inspection Services is a not-to-exceed amount of \$6,000.00.

#### Article 4. Other Provisions

The Services covered by this Work Authorization will be performed in accordance with the provisions set forth in the AGREEMENT referenced above and any of its attachments or schedules. Additional terms or agreement provisions whether submitted purposely or inadvertently, shall have no force or effect. This Work Authorization will become a part of the referenced AGREEMENT when executed by both parties.
