## AMENDMENT NO. 6/ SIXTH EXTENSION TO THE AGREEMENT FOR SPAY/NEUTER SERVICES AND RABIES VACCINATIONS

THIS AMENDMENT entered into this 25th day of February , 2021 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "County" and FIRST COAST NO MORE HOMELESS PETS, 6817 Norwood Avenue, Jacksonville, FL 32208, hereinafter referred to as "Vendor".

WHEREAS, the parties entered into the Contract for Spay/Neuter Services and Rabies Vaccinations, hereinafter referred to as "Agreement", dated January 13, 2014; and

whereas, the Agreement provided for an initial term of two
(2) years beginning January 13, 2014 and ending January 12,
2016, with an option to extend in one (1) year increments upon

WHEREAS, the parties desire to amend and extend the term of the Agreement once again for a period of one (1) year beginning January 13, 2021 and ending January 12, 2022; and WHEREAS, the parties desire to further amend the Agreement to account for an increase in the rates for canine spay and neuter services.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- In accordance with Section 18 of the Agreement, the performance period is hereby extended for an additional one (1) year beginning January 13, 2021 and ending January 12, 2022.
- 2. The new rates for spay and neuter services shall be as follows:

Spay Surgery (Canine)	\$70.00
Neuter Surgery (Canine)	\$50.00
Spay Surgery (Feline)	\$40.00
Neuter Surgery (Feline)	\$40.00

 All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.
