

UNIFORMS**

**THIS AMENDMENT** entered into this 24th day of March \_\_\_\_\_, 2021 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **GALLS, LLC**, located at 1340 Russell Cave Road, Lexington, Kentucky 40505 (hereinafter referred to as "Vendor").
