AMENDMENT NO. 5 TO THE
PROFESSIONAL SERVICE CONTRACT FOR NASSAU COUNTY

THIS AMENDMENT entered into this 31st day of March, 2021 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, hereinafter referred to as "County", and **GOVERNMENT SERVICES GROUP, INC. (GSG)** located at 1500 Mahan Drive, Suite 250, Tallahassee, Florida, 32308, hereinafter referred to as "Consultant".

WHEREAS, the parties entered into an Agreement dated June 24, 2020, for professional services for the development of the County's CARES Act Plan; and

WHEREAS, the Agreement provided for an initial performance period beginning June 29, 2020 and ending July 31, 2020 and the option to extend the performance period upon mutual agreement between the parties; and

WHEREAS, based upon mutual agreement of the parties, the Agreement has been amended to include a performance period ending April 1, 2021; and

WHEREAS, the County, based upon the CARES Act Plan, finds it is in the best interest of the County to extend the performance period to June 1, 2021 and the Consultant has agreed to the extension. parties desire to amend the Agreement once again extending the performance period for an additional two (2) months beginning April 2, 2021 and ending June 1, 2021; and

WHEREAS, the performance period extension is based on "close-out requirements", also with the scope of services set forth in Attachment "A" to the June 20th contract.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The Agreement is hereby amended to extend the performance period for an additional two (2) months beginning April 2, 2021 and ending June 1, 2021.
2. There is no increase in the total compensation.
3. All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.
