## AMENDMENT NO. 5 TO THE PROFESSIONAL SERVICE CONTRACT FOR NASSAU COUNTY

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. The Agreement is hereby amended to extend the performance period for an additional two (2) months beginning April 2, 2021 and ending June 1, 2021.
- 2. There is no increase in the total compensation.
- All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.
