Contract Time

Contract was originally executed on January 16, 2015, and had a completion date of December 31, 2016, which was exended by Time Extension # 1 from December 31, 2016 to December 31, 2019. The contract was extended by Time Extension # 2 from December 31, 2019 to December 31, 2020. Supplemental Agreement #1 further extended the contract time from December 31, 2020 to June 30, 2021. Supplemental Agreement #2 will further extended the contract time from June 30, 2021 to August 30, 2021, based on the written request of Nassau County, see letter attached as "Exhibit A".

Crawford Road from Old Alabama Trail to SR 200 / US 301 Financial Project ID: 430691-2-58-01 (ARQ45) Status Update and Time Extension Request

Dear Ms. Evans:

A project agreement between the Florida Department of Transportation (FDOT) and Nassau County for paving improvements to Crawford Road from Old Alabama Trail to US 301/SR 200 (Phase 2) began on January 16, 2015 with an original completion date of December 31, 2016. A project agreement between the Florida Department of Transportation (FDOT) and Nassau County for paving improvements to Crawford Road from County Road 121 to Old Alabama Trail (Phase 1) began on March 05, 2014 with an original completion date of December 31, 2016.

A three-year time extension was requested for both phases and granted in late 2016 to extend the completion date for both phases to December 31, 2019. The three-year extension was granted to allow for more time to obtain temporary construction easement agreements, additional right-of-way, required permits, complete the construction documents, and construct Crawford Road. Two additional extensions were provided to December 31, 2020 and June 30, 2021 due to the impacts of the COVID-19 pandemic and to allow for some redesign work based on environmental requirements, design speed requirements, and wetland impacts.

The project began construction on November 30, 2020 and is well underway. I believe the project will be completed by August 2021, weather permitting. My concern is not completing the project by June 30, 2021. I am requesting a 90 day extension to the grant to ensure the contractor can complete the project before the grant agreement expires.
