This Work Authorization is to the AGREEMENT between Nassau County and S2li, Incorporated ("Vendor") for Continuing Contract for Professional Engineering Services-Solid Waste Landfills and Other Related Ancillary Facilities for Nassau County, Florida, dated July 26, 2019. The services to be provided under this Work Authorization are as follows:

#### ARTICLE 1. Services Described as:

This Authorization provides for the monthly measuring and recording of the inward gradient conditions at the northern slurry wall surrounding the 11-acre unlined area at the West Nassau Landfill. Based on the April 2020 permit modification, the County is not required to conduct inward gradient measurements for the 42-acre lined area of the West Nassau Landfill.

#### ARTICLE 2. Time Schedule

Work under the Scope of Services provided will begin October 1, 2021 and run through September 30, 2022.

#### **ARTICLE 3. Budget**

The cost estimated to perform the work as described in Attachment "A" is \$11,883.00. A detailed breakdown for each task in conjunction with the estimated labor hours, contractor labor rates, and expenses are attached as Exhibit 1. Costs incurred will be invoiced on a time and material basis. The County will be notified when the overall project budget is nearing its limit.

## **ARTICLE 4.** Other Provisions

The Services covered by this Work Authorization will be performed in accordance with the provisions set forth in the AGREEMENT referenced above and any of its attachments or schedules. Additional terms or contract provisions whether submitted purposely or inadvertently, shall have

no force or effect. This Work Authorization will become a part of the referenced AGREEMENT when executed by both parties.

# Inward Gradient Measurements for the West Nassau Landfill – 11-Acre Unlined Area

# Service Period: FY2022 (October 1, 2021 through September 30, 2022)

# Service Period: FY2022 (October 1, 2021 through September 30, 2022)

This Work Authorization (WA) tasks S2L, Incorporated (S2Li) to assist the County by measuring and recording the monthly inward gradient conditions at the northern slurry wall surrounding the West Nassau Landfill (Landfill) 11-acre unlined area. Based on an April 2020 permit modification, the County is not required to conduct inward gradient measurements for the 42-acre lined area of the West Nassau Landfill. Under the scope of services for this Work Authorization, S2Li will perform the following:

#### Monthly Monitoring of Well Water Elevations by Taking Field Measurements

S2Li will measure and record the water level elevations within wells at eight locations (two wells per sampling location) on each side the northern slurry wall for the 11-acre unlined area of the Landfill. These measurements will be conducted monthly, while S2Li is on-site for purposes of monitoring and testing the landfill gas extraction wells. A copy of the field form filled out by S2Li's personnel will be provided to the County upon leaving the Site. S2Li's personnel will input the monthly slurry wall monitoring well water elevations into the County provided spreadsheet template and the electronic form will be sent to the County.

## SCHEDULE

The services under this Work Authorization would be conducted monthly during the service period of October 1, 2021 through September 30, 2022.

## COST ESTIMATE

The cost estimate to conduct the Work as described in the above-listed Scope of Services is \$11,833.00. A detailed breakdown for each task in conjunction with the estimated labor hours, contract labor rates, and expenses are included in the attached Exhibit 1. Costs incurred will be invoiced on a time and material basis. The County will be notified when the overall project budget is nearing its limit.
