AMENDMENT NO. 7 / SEVENTH EXTENSION TO THE LEASE AGREEMENT FOR THE NASSAU OAKS VOLUNTEER FIRE DEPARTMENT

THIS AMENDMENT entered into this July day of September. 2021 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and NASSAU OAKS VOLUNTEER FIRE DEPARTMENT, 56300 Nassau Oaks Drive, Callahan, Florida 32011, (hereinafter referred to as "Nassau Oaks").

WHEREAS, the parties entered into an Agreement dated November 26, 2014; and

whereas, the Agreement provided for an initial term of one (1) year beginning October 1, 2014 and ending September 30, 2015, with an option to extend upon mutual agreement between the parties; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties agreed to extend the term of the Agreement for additional one (1) year periods beginning October 1, 2015 and ending September 30, 2021; and

WHEREAS, the parties desire to extend the term of the Agreement for an additional one (1) year period beginning October 1, 2021 and ending September 30, 2022.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agraements herein contained, the parties hereto agree as follows:

- 1. In accordance with the terms of the Agreement dated November 26, 2014, the term of the Agreement is hereby extended for an additional one (1) year period beginning October 1, 2021 and ending September 30, 2022.
- All other provisions of said Agreement not in conflict with this Agreement shall remain in full force and effect.
