SECOND AMENDMENT TO THE PROFESSIONAL SERVICE AGREEMENT FOR NASSAU COUNTY, FLORIDA

THIS AMENDMENT entered into this 13th day of December , 2021 by and between the Board of County Commissioners of Nassau County, a political subdivision of the State of Florida, hereinafter referred to as "County", and Barth Associates, LLC located at 10030 SW 52nd Road, Gainesville, Florida 32608, hereinafter referred to as "Consultant".

WHEREAS, the parties entered into an Agreement dated February 5, 2021, for professional services on an "as needed" basis for facilitation, technical assistance, and guidance related to strategic planning services planning, program development, and operational management; and

WHEREAS, the parties agreed to amend the terms of the original Agreement to provide for additional legal services and executed the First Amendment to the Professional Service Agreement for Nassau County, Florida on March 18, 2021; and

WHEREAS, staff desires Consultant to provide review of parks and open space system plans proposed for the Wildlight ENCPA DSAP 2; and

WHEREAS, Consultant asserts to possess the knowledge, skills, expertise, and resources to provide County with such review: and

WHEREAS, the parties desire to further amend the Agreement to include review of parks and open space systems proposed and clarify compensation of expenses; and

WHEREAS, the parties desire to further amend the Agreement to increase the total sum compensation to not to exceed \$75,000.00 per year to account for the additional services.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- The Agreement is hereby amended to provide review of parks and open space system
 plans for Wildlight ENCPA DSAP 2 according to the Scope of Services outlined in
 Attachment "A" attached hereto.
- Compensation for the additional services shall be hourly inclusive of reasonable expenses as outlined in Attachment "A" attached hereto.
- Article 5, Section 5.1 of CM2962 is amended to read:
 Consultant shall be compensated on an hourly basis in accordance with the Fee Schedule outlined in Attachment "A", plus reasonable expenses, with a total sum not to exceed \$30,000.00 per year.
- The Agreement is hereby further amended to increase the total sum compensation to not to exceed \$75,000.00 per year.
- All other provisions of said Agreement not in conflict with this Amendment shall remain in full force and effect.

- Participate in the sufficiency review for the project, including requests for additional information
- Testify at public meetings
- Prepare guiding principles, site assessments, conceptual vision plans, prototypes, or conceptual sketches
- Other parks and open space system planning services as requested by the county

FEE SCHEDULE:

BA will provide the services outlined above on an hourly basis, plus direct expenses, in accordance with the following hourly rate schedule. Total fees shall not exceed thirty thousand dollars (\$30,000) without the county's written consent. Expenses – which are included in the total fees - shall not exceed three thousand dollars (\$3,000) without the county's written consent.
