Reason for Change Order: The final cost estimate for project construction was determined to be approximately \$2.8M. A secondary estimate was provided, demonstrating safety edge can reduce the construction cost to approximately \$2.35M, saving roughly \$450,000. To reduce project expenditures, it was determined to move forward with safety edge instead of shoulder, which will require updating the final plan set. Engineering Services has requested to extend the Work Authorization for an additional sixty (60) days and allocate an additional \$11,172.40 for redesign of the plans. This would replace the Work Authorization end date of 12/31/2021 with 3/1/2022.

Attached is our invoice #2 that shows about half of the fee remaining the end of November. I anticipate to have all of the ROW effort completed and submitted by mid January. We have reviewed all of your comments and have no issues with any of them. We have already made most of those revisions but revising the plans/cross sections/quantities to remove the paved shoulder and add safety edge will take about 2-3 weeks of additional time - which will require an additional budget amount of \$11,172.40 as shown on the attached pdf. As far as time goes, my suggestion would be to extend the time through the end of February to allow us to make these revisions and resubmit in case you have any more comments related to the safety edge revisions. Once all the ROW is acquired and is ready to bid, you can issue a separate work order for bid and construction phase services – if that works for yall.

We have reviewed the 90% plans and offer the attached comments for consideration. Please let us know if you would like to schedule a call to walk through any or all of them.

Most notably, the project seems to be significantly over budget. The estimate is for \$3M, but we only have \$1.8M in funding. We are thinking we may need to tighten the road up to have a typical section similar to that of Crawford Rd., utilizing a safety edge. Please let us know your thoughts.
