### UNITED STATES DEPARTMENT OF INTERIOR **U.S. GEOLOGICAL SURVEY** AMENDMENT OF JOINT FUNDING AGREEMENT FOR WATER RESOURCES INVESTIGATIONS

This amendment is for the agreement dated October 1, 2021.

- 1. The parties hereto agree that subject to availability of appropriations and in accordance with their respective authorities there shall be maintained in cooperation for the investigation of water resources as related to underground waters, surface waters and their chemical characteristics, herein called the program.
- 2. Paragraph 2a of the agreement is hereby \_\_\_\_ increased/ \_\_\_ decreased by \$0.00 to read as follows:

(a) 0.00 by the party of the first part during the period

October 1, 2021 to September 30, 2022

Paragraph 2b of the agreement is hereby X increased/ decreased by \$6,940 to read as follows:

(b) \$10,510 by the party of the second part during the period

October 1, 2021 to September 30, 2022

Billing for this agreement will be rendered **annually**. Payments of bills are due within 60 days after the billing date. If not paid by the due date, interest will be charged at the current Treasury rate for each 30-day period, or portion thereof, that the payment is delayed beyond the Due date. (31 USC 3717; Comptroller General File B-212222, August 23, 1983).
