FIRST AMENDMENT TO THE PROFESSIONAL SERVICE AGREEMENT FOR NASSAU COUNTY, FLORIDA

THIS AMENDMENT entered into this _____ day of ______, 2021 by and between the **Board of County Commissioners of Nassau County**, a political subdivision of the State of Florida, hereinafter referred to as "County", and **Barth Associates, LLC** located at 10030 SW 52nd Road, Gainesville, Florida 32608, hereinafter referred to as "Consultant".

WHEREAS, the parties entered into an Agreement dated April 5, 2021, for professional services to develop a plan to enhance the American Beach Cultural Heritage Experience; and

WHEREAS, the Contract provided for an initial term beginning on April 5, 2021 and ending on December 31, 2021 with the option to extend the performance period upon mutual agreement of the parties; and

WHEREAS, The County Manager's Office has determined that it is necessary to extend the performance period beyond December 31, 2021; and

WHEREAS, the parties mutually agree to extend the performance period for an additional one (1) year period beginning on January 1, 2022 and ending on December 31, 2022; and

WHEREAS, the parties desire to amend the Agreement to provide additional clarification to Article 5 - Compensation; and

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- The performance period of the Contract shall be extended for an additional one (1) year period beginning on January 1, 2022 and ending December 31, 2022.
