WHEREAS, on September 24, 2021 the First Amendment to the Contract for Disaster Debris Management (Removal Services) was executed to provide the first one year extension, ending September 23, 2022; and

WHEREAS, Emergency Management has determined that it is necessary to extend the performance period beyond September 24, 2022; and

WHEREAS, the parties mutually agree to extend the performance period for an additional one (1) year period beginning on September 24, 2022 and ending on September 23, 2023.

**NOW, THERFORE**, **FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period of the Contract shall be extended for an additional one (1) year period beginning on September 24, 2022 and ending September 23, 2023.

2. All other provisions of the original Contract not in conflict with this Amendment shall remain in full force and effect.
