

**AMENDMENT TO SPONSORSHIP AGREEMENT**

**THIS AMENDMENT TO SPONSORSHIP AGREEMENT** (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter “NCBOCC” or “County”), and The Hagerty Group, LLC dba Hagerty Events, LLC, a business having its primary business location at 121 Drivers Edge, Traverse City, Michigan 49684 (hereinafter “Hagerty”).

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Sponsorship Agreement for the purpose of promoting and conducting The Amelia (hereinafter “Event”) dated February 27, 2023 (hereinafter “Agreement”); and

**WHEREAS**, the Parties now desire to enter into this Amendment in order to renew the term of the Agreement for one (1) year and to provide Hagerty with an additional sponsorship of fifty-five thousand dollars (\$55,000) for the 2024 Event pursuant to the terms and conditions contained in the Agreement and hereinbelow.

**NOW, THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

**SECTION 1.** Pursuant to Section 10 of the Agreement, the term shall be renewed for one (1) year and the County shall supply Hagerty with a sponsorship of fifty-five thousand dollars (\$55,000) for the 2024 Event.


**SECTION 2.** All other terms and conditions of the Agreement not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.


