# SECOND AMENDMENT TO CONTRACT FOR CONSERVATION LAND ACQUISITION & MANAGEMENT CONSULTING SERVICES

THIS SECOND AMENDMENT TO THE CONTRACT FOR CONSERVATION LAND ACQUISITION & MANAGEMENT CONSULTING SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and North Florida Land Trust, Inc., a business having its primary business location at <u>843 W. Monroe Street</u>, Jacksonville, FL 32202 (hereinafter the "Consultant").

### WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Conservation Land Acquisition & Management Consulting Services dated June 5, 2023 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Section 7.1 of the Contract is hereby amended to increase the compensation amount by Thirty-Six Thousand and 00/100 dollars (\$36,000) to provide consulting services as needed for the duration of the contract term, and the County shall now compensate the Consultant in an amount not to exceed Eighty-Four Thousand and 00/100 dollars (\$84,000).

**SECTION 2.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
