# FIRST AMENDMENT TO CONTRACT FOR RENTAL OF ADA-COMPLIANT PORTABLE TOILETS AND RELATED SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR RENTAL OF ADA-COMPLIANT PORTABLE TOILETS AND RELATED SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and Floaters Portable Sanitation, Inc., a business having its primary business location at 1509 Faye Road, Jacksonville, FL 32218 (hereinafter the "Vendor").

#### WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for the Rental of ADA Compliant Portable Toilets and Related Services dated August 18, 2023 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Section 4 of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract to an amount not to exceed Sixty-Five Thousand, Eight Hundred Dollars and 00/100 (\$65,800.00).

**SECTION 2.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
