**THIRD AMENDMENT TO CONTRACT FOR
BEACH FACILITY RESTROOM CLEANING SERVICES**

THIS THIRD AMENDMENT TO THE CONTRACT FOR BEACH FACILITY RESTROOM CLEANING SERVICES (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the “County”), and Sea Bandit Construction, LLC, a business having its primary business location at 85143 Derrick Road, Yulee, Florida 32097 (hereinafter the “Vendor”).

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Beach Facility Restroom Cleaning Services dated February 10, 2020 (hereinafter “Contract”); which was amended on July 11, 2022 to add additional restrooms and amended again on February 27, 2023 to remove the additional restrooms, increase the overall contract amount and extend the performance period of the original contract through February 29, 2024; and

WHEREAS, the Parties now desire to further amend the Contract terms and conditions subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 20. of the Contract is hereby amended to extend the performance period of the Contract for an additional one (1) year and the Contract shall now terminate on February 28, 2025.

SECTION 2. Section 5. of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract by Sixty-Nine Thousand, Fifteen Dollars and 00/100 (\$69,015.00) to account for the final extension of the performance period, and the County shall now compensate the Vendor in an amount not to exceed Three Hundred Eighty-Four Thousand, Thirty Dollars and 00/100 (\$384,030.00).

SECTION 3. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.



From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
