**FIRST AMENDMENT TO CONTRACT FOR PROFESSIONAL INSPECTION
AND MAINTENANCE SERVICES FOR THE FIRE SUPPRESSION SYSTEMS IN
NASSAU COUNTY, FLORIDA**

THIS FIRST AMENDMENT TO THE CONTRACT FOR PROFESSIONAL INSPECTION AND MAINTENANCE SERVICES FOR THE FIRE SUPPRESSION SYSTEMS IN NASSAU COUNTY, FLORIDA (hereinafter “Amendment”) is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the “County”), and Pye Barker Fire & Safety, LLC, a business having its primary business location at 8936 Western Way Suite 5, Jacksonville, Florida 32256 (hereinafter the “Vendor”).

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for professional inspection and maintenance services for fire suppression systems dated March 3, 2022 (hereinafter “Contract”); and

WHEREAS, the Contract was not formally amended to further extend the performance period, but the Parties continued to perform their contractual duties and responsibilities under the Contract, and the Parties agree by this performance there was an implied extension of the performance period of the Contract; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 4. of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on March 2, 2025.

SECTION 2. Section 5. of the Contract is hereby amended to increase the compensation amount for the goods/services to be provided under the Contract by Twenty-Three Thousand, Nine Hundred Twenty-Three Dollars and 00/100 (\$23,923.00) and the County shall now compensate the Vendor in an amount not to exceed Sixty-Nine Thousand, Six Hundred Ninety-Nine Dollars and 50/100 (\$69,699.50).

SECTION 3. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you.
