SECOND AMENDMENT TO PIGGYBACK AGREEMENT PURSUANT TO NASSAU COUNTY PURCHASING POLICY

THIS SECOND AMENDMENT TO THE PIGGYBACK AGREEMENT PURSUANT TO NASSAU COUNTY PURCHASING POLICY (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and GOVERNMENTJOBS.COM, INC. dba NEOGOV, a business having its primary business location at 2120 Park Place, Suite 100, El Segundo, CA 90245, (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement for Applicant Tracking and Onboarding Software Services dated August 29, 2022 (hereinafter "Contract"); and

WHEREAS, the Agreement provided for an initial performance period beginning on August 29, 2022 and ending on March 15, 2023 with the option to extend the performance period upon mutual agreement of the parties in one (1) year increments for two (2) additional years; and

WHEREAS, the Agreement was extended for one (1) year beginning on March 16, 2023 with a termination date of March 15, 2024; and

WHEREAS, as of the date of this Amendment the Parties have continued to perform under the terms and conditions of the Agreement and now desire to formally renew the same and extend the performance period until March 15, 2025; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Section 2 (i) of the Piggyback Agreement is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on March 15, 2025. Vendor will be using rates previously established under the initial Contract, a copy of which is attached hereto as Exhibit A.

SECTION 2. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
