THIS THIRD AMENDMENT TO THE CONTINUING CONTRACT FOR PROFESSIONAL ENGINEERING SERVICES FOR NASSAU COUNTY, FLORIDA (hereinafter "Amendment") is made by and between the **Board of County Commissioners of** Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and EltonAlan, Incorporated, a business having its primary business location at 3653 Regent Boulevard, #606, Jacksonville, Florida 32224 (hereinafter the "Vendor").

WHEREAS, the Parties previously entered into a Continuing Contract for Professional Engineering Services for Nassau County, Florida dated January 8, 2018 (hereinafter "Contract") which was subsequently amended on December 22, 2020 and December 15, 2021; and

WHEREAS, the Contract and subsequent amendments provided for a performance period beginning on January 8, 2018 and ending on January 7, 2023; and

WHEREAS, the Contract was not formally amended to further extend the performance period, but the Parties continued to perform their contractual duties and responsibilities under the Contract, and the Parties agree by this performance there was an implied extension of the performance period of the Contract; and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

NOW, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

SECTION 1. Article 4. of the Contract is hereby amended to extend the performance period of the Contract through January 7, 2025.

SECTION 2. All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
