#### FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING BETWEEN FLORIDA STATE COLLEGE AT JACKSONVILLE AND NASSAU COUNTY FIRE RESCUE

#### THIS FIRST AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING

(hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), on behalf of the Nassau County Fire Rescue (hereinafter referred to as "NCFR") and The District Board of Trustees at Florida State College at Jacksonville, (hereinafter referred to as "FSCJ").

#### WITNESSETH:

**WHEREAS**, the Parties previously entered into a Memorandum of Understanding for an EMS ride-along program dated September 1, 2021 (hereinafter "MOU"); and

WHEREAS, the Parties now desire to amend the MOU terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the MOU as follows:

**SECTION 1.** Section III.A. of the MOU is hereby amended to extend the term of the MOU for an additional three (3) (years) and the MOU shall now terminate on August 31, 2027.

**SECTION 2.** All other terms and conditions of the MOU not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

#### **Getting paper copies**
