**THIRD AMENDMENT TO TRASH HAUL ASSISTANCE CONTRACT**

**THIS THIRD AMENDMENT TO THE TRASH HAUL ASSISTANCE CONTRACT** (hereinafter “Amendment”) is made by and between the **Board of County Commissioners of Nassau County, Florida**, a political subdivision of the State of Florida (hereinafter the “County”), and **Meridian Waste Florida LLC**, a business having its primary business location at 463106 SR 200 Yulee, FL 32097 (hereinafter the “Vendor”).

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a *Contract for Trash Haul Assistance* on September 28, 2020 (hereinafter the “Contract”); and

**WHEREAS**, the Contract provided for an initial performance period of three (3) years beginning October 1, 2020 and terminating on September 20, 2023 with the option to extend the performance period for two (2) additional one (1) year periods upon mutual agreement between the Vendor and the County; and

**WHEREAS**, on June 1, 2022, the Contract was amended to increase the per pull rate for the 20-yard roll-off open top bin, 30-yard roll-off open top bin and 30-yard trash compactor bin; and

**WHEREAS**, the Parties entered into that certain Second Amendment to Trash Haul Assistance Contract, dated August 22, 2023, which extended the term of the Contract for the first of two (2) additional one (1) year periods, to terminate on September 30, 2024; and

**WHEREAS**, the Parties now desire to further amend the Contract terms and conditions subject to the provisions contained herein.

**NOW, THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** Section 20 of the Contract is hereby amended to extend the performance period for an additional one (1) year term (the second of two (2) additional one (1) year extension periods allowed under the Contract), said term to begin on October 1, 2024 and terminate on September 30, 2025.


**SECTION 2.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.



## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, County of Nassau (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. ### **Consequences of changing your mind**
