FIRST AMENDMENT TO AFFILIATION AGREEMENT BETWEEN CAMSEN CAREER INSTITUTE AND NASSAU COUNTY FIRE RESCUE

THIS FIRST AMENDMENT TO AFFILIATION AGREEMENT (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, on behalf of Nassau County Fire Rescue (hereinafter "Nassau County Fire Rescue"), and Camsen Career Institute, located at 4401 Salisbury Road, Suite #300, Jacksonville, FL 32216 (hereinafter "Camsen Career Institute").

WITNESSETH:

WHEREAS, the parties previously entered into an Affiliation Agreement dated July 8, 2024, with an effective date from October 1, 2024 to September 30, 2027 (hereinafter "**Agreement**"); and

WHEREAS, the parties now desire to amend the Agreement to make the effective date earlier, subject to the terms and conditions contained herein.

NOW, **THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the parties do agree to amend the Agreement as follows:

SECTION 1. The first paragraph of the Agreement, labeled "Participating Agencies," is amended to change its effective date from beginning on October 1, 2024 to beginning on the date that this Amendment is fully executed. The ending date of the Agreement shall remain September 30, 2027.

SECTION 2. All other terms and conditions of the Agreement not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
