

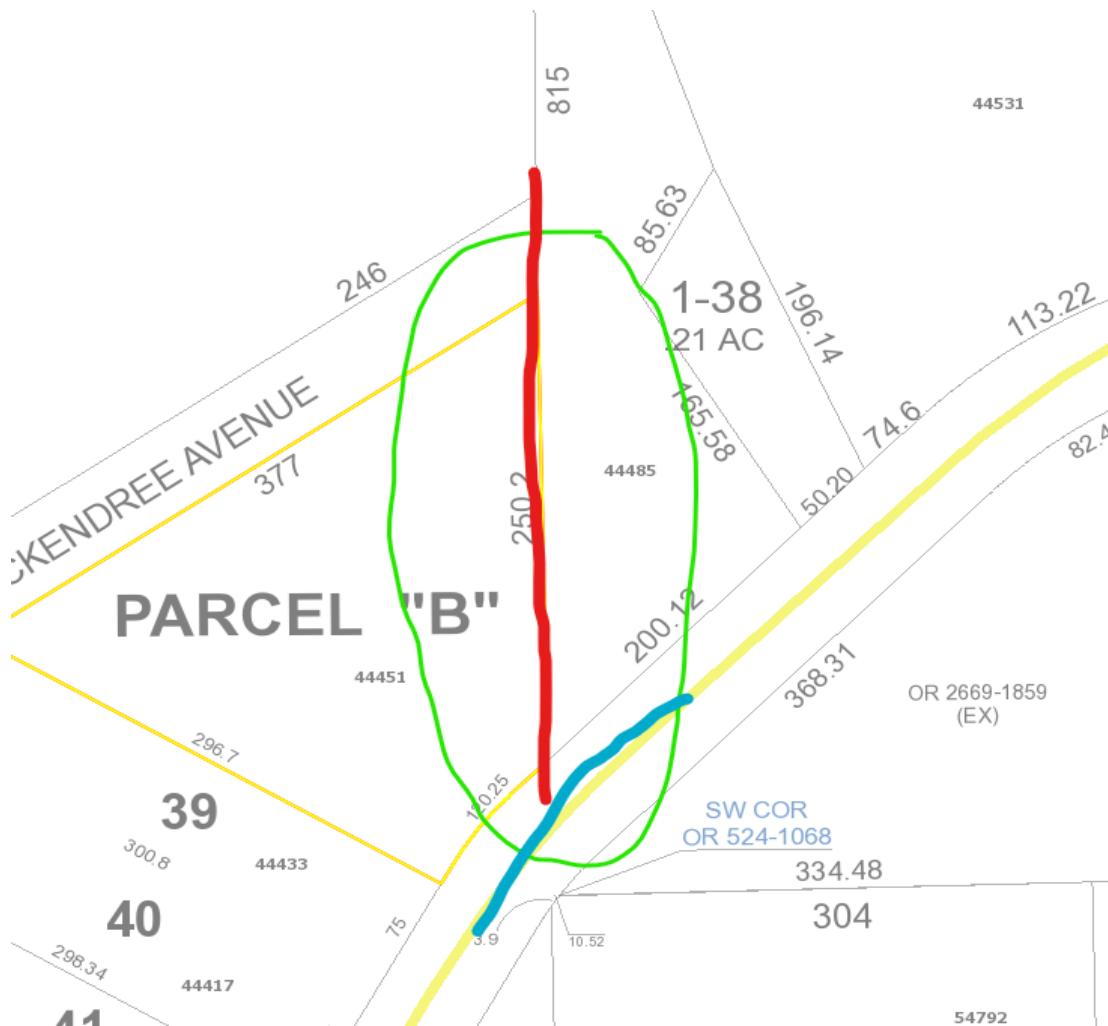

Getting paper copies
