# FIRST AMENDMENT TO CONTRACT FOR MESSAGE BOARDS AND INSTALLATION SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR MESSAGE BOARDS AND INSTALLATION SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and PURVIS SYSTEMS INCORPORATED, a business having its primary business location at 88 SILVA LANE MIDDLETON, RI 02842 (hereinafter the "Vendor").

The County shall now compensate the Vendor in an amount not to exceed Seventy-seven thousand three hundred thirty-three dollars and 27/100 (\$77,333.27). **SECTION 2.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
