

**SECOND AMENDMENT TO SPONSORSHIP AGREEMENT**

**THIS SECOND AMENDMENT TO SPONSORSHIP AGREEMENT** (hereinafter “Amendment”) is made by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida (hereinafter “NCBOCC” or “County”), and **HAGERTY EVENTS, LLC**, formally known as **THE HAGERTY GROUP, LLC**, d/b/a **HAGERTY EVENTS, LLC**, a business having its primary business location at 121 Drivers Edge, Traverse City, Michigan 49684\_(hereinafter “Hagerty”).

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Sponsorship Agreement for the purpose of promoting and conducting The Amelia\_(hereinafter “Event”) dated February 27, 2023 (hereinafter “Agreement”) which was previously amended to sponsor the 2024 event; and

**WHEREAS**, pursuant to Resolution 2023-137, the AITDC previously recommended and pursuant to Resolution 2023-162, the NCBOCC approved the ability to amend the Agreement as set forth below; and

**WHEREAS**, the Parties now desire to further amend the Agreement to extend the term for one (1) year and to provide Hagerty with a sponsorship of Fifty-Five Thousand Dollars and 00/100 (\$55,000.00) for the 2025 Event pursuant to the terms and conditions contained in the Agreement and hereinbelow.

**NOW, THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

**SECTION 1.** Section 10 of the Agreement shall be amended to extend the term of the Agreement for an additional one (1) year and the Agreement shall now terminate on September 30, 2025.

**SECTION 2.** Section 4 of the Agreement shall be amended to provide Hagerty with a sponsorship in the amount of Fifty-Five Thousand Dollars and 00/100 (\$55,000.00) for the 2025 Event.


**SECTION 3.** All other terms and conditions of the Agreement not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.


