#### **Scope of Services**

# Miscellaneous On-Call Services for Solid Waste In Fiscal Year 2025

County Contract and Work Authorization Number: CM3621-WA04 S2Li Project Number: 24-1059

Work Authorization Period: Fiscal Year 2025 (October 1, 2024 through September 30, 2025)

This Work will provide the County and S2L, Incorporated (S2Li) with the ability to respond to small on-call assignments whose performance needs are immediate, such as responding to a regulatory inquiry, limited evaluations, or report deadlines and emergency contractor repair or assistance services. This Work Authorization is intended to allow S2Li to continue the provision of such services when the need arises.

#### **Scope of Services**

#### Task 1 - Miscellaneous On-Call Services

S2Li is to provide miscellaneous services to address assignments including but not necessarily limited to updating existing reports, preparation of new reports, addressing rule changes, attending meetings not addressed in other work authorizations, emergency contractor repair or assistance services, and other solid waste-related assignments on an as-needed basis at the County's request. The total work effort is limited to the budget limit provided in this work authorization. S2Li shall provide the County with an estimate of the anticipated engineering fees and schedule associated with each on-call assignment. S2Li shall not proceed with any services prior to the receipt of authorization from the County.

#### Schedule

Work under the Scope of Services provided above will begin October 1, 2024 and run through the fiscal year period ending September 30, 2025.

#### **Cost Estimate**

The cost estimate to conduct the Work as described in the above-listed Scope of Services is not to exceed **\$25,000**. A detailed breakdown of the estimated labor hours and expenses is included in the attached Exhibit 1 but actual labor hours, labor categories, and type of expenses used will vary for each assignment. Fees for services shall be on a time and material basis according to the hourly labor rates and schedule of reimbursable expenses identified in Contract No. CM3621 as amended. The County will be notified when the overall project budget is nearing its limit.

For accounting purposes, each small assignment implemented under this Work Authorization may be separately tracked.
