Box 23627, Jacksonville, Florida 32241-3627 (hereinafter the "Vendor").

WITNESSETH:

WHEREAS, the Parties previously entered into a Contract for Fuels dated December 14, 2020 (hereinafter "Contract"); and

WHEREAS, the Parties previously executed an Amendment to Contract for Fuels on August 28, 2023, in order to extend the term until September 30, 2024; and
